

1. Introduction

The Global Environmental Justice (GEJ) Group is a research group at the School of International Development in the University of East Anglia. We are an interdisciplinary group of scholars interested in the links between social justice and environmental change at local and global scales.

We study injustices in different areas of contemporary environmental governance, and we are actively involved in envisioning and supporting more effective forms of environmental governance and social mobilisation. We seek to place justice analysis at the heart of environmental governance, with a particular emphasis on promoting environmental justice for those suffering from poverty and disempowerment. Our interest in identifying global connections and dynamics is combined with explicit attention to local social and environmental struggles.

We value exchanging perspectives and collaborating with a number of actors including local communities, land and resource users, other researchers, environmental activists, policy-makers, development professionals and students.

This annual report covers the period between August 2018 and July 2019, and summarises the breadth and depth of research and engagement carried out by the members. A highlight of the year was the international Environmental Justice conference *Transformative Connections*, hosted by the group at UEA in July 2019, with over 150 delegates; you can read more about this in section 6. Our Environmental Justice MOOC remains popular with thousands of learners joining from around the world each year; you can read more about this in section 7.

After four years of directing the GEJ Group Adrian Martin is standing down, and Gareth Edwards is now Director of the group.

The GEJ group hosted the 2019 Environmental Justice Conference 'Transformative Connections' at UEA on 2 - 4 July.






